FFA DIVISION RULES & REGULATIONS

Adoption of Rules

The Evergreen State Fairgrounds, hereinafter referred to as Fair, is a division of Snohomish County government. The fairgrounds facility operates year-round with a full-time staff of twenty-two.

Each year special emphasis is given to the agricultural exhibits, as agriculture is one of Washington State's largest industries. Exhibitors are encouraged to showcase all aspects of the agriculture industry of yesterday, today and tomorrow. Information and programs are available to all citizens without discrimination regarding sex, race, color, disability, national origin or religion.

Fair management is authorized to adopt and interpret such rules and regulations, as it deems necessary for the safe and orderly operation of the annual fair. This year's theme is Where the Magic Comes Alive in 2025! Good luck on your Fair adventure!

GENERAL RULES & INFORMATION

The following rules and regulations apply to all non-commercial exhibitors/exhibits participating in the current year's fair; exhibitors are required to familiarize themselves with these rules and regulations. Fair management reserves the final and absolute right to interpret these rules and regulations.

GROUNDS SUPERVISION

- The general supervision of the grounds and the entire exhibition are vested in Fair management.
- Outside agencies are contracted to provide medical care and law enforcement during the annual fair.
- Property of the Fair (i.e. flower baskets, landscape materials, fire extinguishers) may not be removed.

ADMISSION AND TRAFFIC

- The east and west pass gates will open at 8:00am for fair participants. The green (livestock) and white (equestrian) gates will open at 6:00am. The outside pedestrian gates of the FAIR open at 10:00am daily for the general public. Admission prices are posted at entrance gates.
- Vehicles, including automobiles, trucks, recreational vehicles, trailers, golf carts, motor scooters, scooters, skateboards, skates, bicycles, etc., are not allowed inside the fairgrounds excluding parking lots at any time.
- Overnight parking is allowed only in Fair RV lots or as provided in writing by Fair management. **As of Aug. 1, only cash, cashier's checks, money orders or VISA/MC will be accepted.** A \$35 service fee will be charged for all NSF checks. Premiums may be withheld until all NSF charges and/or entry fees are cleared.
- Area traffic/parking signs are to be observed at all times. Designated fire lanes must be kept clear.

GROUNDS & BUILDING USE

- All FFA exhibitors must be off the grounds by 11:00 pm daily. FFA exhibitors who remain in the camping area overnight must be accompanied by an adult chaperone.
- Buildings, barns, carnival and commercial exhibit areas are off limits to exhibitors after 11:30 pm.
- Tobacco use and smoking is prohibited on the Evergreen State Fairgrounds.
- Possession of alcoholic beverages, illegal controlled substances, firearms or lethal weapons is prohibited.
- NO SLEEPING in any buildings or barns allowed (per Fire Marshal's Office).

SKATEBOARDS, SCOOTERS, ETC

- NO skateboards, roller skates, roller blades, bicycles, motorcycles, scooters or similar recreational vehicles or toys are allowed on the grounds.

DOGS AND OTHER PETS

- Dogs, birds, or other pets not intended for exhibition will be denied entry to the fairgrounds, please leave your animal at home for its own protection. Exceptions are made for on duty police dogs, "assistant" animals (as defined by ADA), trained animals in scheduled acts and dogs entered in competition.
- No animals in restrooms or showers.

ADVERTISING AND SALES

No person will be permitted to distribute advertising matter, handbills, fliers or herald upon the grounds.

- The tacking or posting of any advertisement, bill, sign, banner, etc. is prohibited.

- Advertising and Sales – sales, solicitations, commercial product display, raffles, drawings, etc., by any entity on the Fairgrounds is prohibited, except as authorized by a written license agreement issued by Fair Management.

HOLD HARMLESS AND NON-LIABILITY

- EXHIBITOR'S RISK – Exhibits at the Fair are entered and displayed at the risk of the exhibitor. Fair cannot accept responsibility for loss or damage resulting from conditions imposed by large crowds, the arrangement of the displays, the great number of exhibits, disease, weather or any other condition.
- Prior to entry, exhibitor should consider the sentimental and monetary value of the exhibit, as Fair provides no restitution for loss or damage.
- HOLD HARMLESS – By submitting an entry into the Fair, the Exhibitor has agreed to protect, save harmless, indemnify, and defend, at their own expense, Snohomish County, its elected and appointed officials, officers, employees, and agents from any loss or claim for damages solely caused by the negligence or willful misconduct of Snohomish County, its elected and appointed officials, officers, employees, or agents; and that Snohomish County shall not be held liable or responsible for any loss, injury or damage to persons, animals or property on the fairgrounds by reason of fire, theft, vandalism, weather, wind, flood, earthquake, collision damage, disease or illness, nor does it assume any liability for injury to persons, animals or property while on any portion of the fairgrounds or while using its facilities (S.C.C. 2.33.050).

FORFEITURE OF PRIVILEGES OR AWARDS

- Any person who violates any general or special rule will forfeit all privileges and premiums and be subject to such penalty as Fair management may order.

BANKING – CHECK CASHING SERVICES are **not** available on the fairgrounds.

- ATMs are located at various sites on the fairgrounds.

PUBLIC SAFETY

FIRE PROTECTION

- All matters of fire protection are under the direct supervision of the State and County Fire Marshal offices. The Fair will use precaution to guard against fire but will not be responsible for any loss or damage suffered by such an event.

FIRST AID

- Under no circumstances shall an individual attempt to treat a person that is "down". In the case of a medical situation exhibitor shall immediately contact the nearest department superintendent, clerk or Fair employee. They are responsible for making the appropriate contacts.
- Exhibitor may help situation by keeping the area cleared until medical assistance arrives.
- The first aid office is available to all exhibitors and patrons during public hours of the fair. Report to building #407 for assistance.

LAW ENFORCEMENT AND SECURITY

- The Snohomish County Sheriff's Office is contracted to provide security and crowd control on the fairgrounds. They are based in building #407 near the Administration Building.

LOST PERSON CENTER

- All persons who are lost, or misplace another person, may contact the Lost Person Center operated by Valley General Hospital. Center is located near building #407.

LOST AND FOUND

- The lost and found department is open at the West Gate Building 201 from 8:00 am – 10:00 pm.
- The Fair office will retain lost/found items beginning Labor Day for a period of (30) thirty days.
- Owner may claim item by verbally identifying it, prior to viewing, west gate Building 201 or after Fair at the Fairgrounds Administration Building.

DEPARTMENTS OF EXHIBITION RULES

ELIGIBILITY

- Participants must be an "Official" FFA member in good standing with their chapter.
- All entries must be approved by their Chapter Advisor.
- Entries must be the FFA project of the student under whose name they are entered.
- An FFA exhibitor will not be permitted to exhibit products or livestock from the same enterprise or project in both 4-H and FFA divisions.
- Examples of **Project** or **Enterprises**: beef breeding, beef marketing, sheep breeding, sheep marketing, swine breeding, swine marketing, production dairy cow, dairy heifer and calf, poultry breeding, poultry marketing, horse breeding and production, horse performance, vegetable gardening, container gardening, home horticulture, etc.
- Examples of **Enterprise**: chickens, turkeys, geese, ducks, rabbits, sheep, swine, beef, dairy replacements, dairy production, wheat, barley, etc.
- Refer to the appropriate term used by both organizations.
- Exhibitor must have an FFA Advisor present each day to be eligible to show.

DURATION OF STAY

- All exhibits must remain on display during the FFA section of Fair.
- Exhibits must be ready for public viewing daily between the hours of 10:30 am and 9:00 pm.

ENTRY OF EXHIBIT

- Entry must be received by the last day of July.
- Official Fair entry is to be done on-line at <http://egreen.fairwire.com> or through the fair website at www.evergreenfair.org.
- Exhibitors must also complete entry for record books at the time of livestock registration.
- Record books are found online at www.evergreenfair.org and must be submitted by Thursday at noon.
- Exhibitors are also encouraged to register for judging contests, posters and exhibits, public education at time of livestock entry.
- For exhibitors expecting to earn more than \$500, **W9 forms are required.**
- All FFA members must do Fitting & Showing in all species entered to receive premiums.
- FFA chapters outside Snohomish County, excluding Cedarcrest & Mount Si FFA, will not be permitted to exhibit animals except on a space available basis.
- Entry of exhibits is allowed during the dates and times specified in the individual department sections of this book.
- Fair management reserves the right to accept entries late if it is found such action would not cause injury to other exhibitors.
- All exhibits must be entered for competition in the name of the exhibitor, manufacturer, or leasee.
- Anyone attempting to deceive the fair in regard to ownership, manufacturer, or leasee shall forfeit all claims as an exhibitor.
- Exhibitor will enter categories based on the following:
 - Novice: An exhibitor who has never shown the species prior to January 1st of the current year.
 - Junior: Exhibitors who are incoming freshman and were 9th and 10th graders of the previous school year.
 - Senior: Exhibitors who were 11th and 12th graders the previous school year and those who are graduates.
- Entries are to be double checked by exhibitors at haul in day in Building 511. Exhibitors will initial corrected entries. Following this NO Change will be allowed to entries.
- No Poster, No Premiums.

OBJECTIONAL EXHIBIT

- Fair management reserves the right to remove from display area any exhibit or animal that may be falsely entered, or may be deemed unsuitable or objectionable, without assigning a reason, therefore.

ERRONEOUS ENTRY

- Exhibits that have been erroneously entered may be transferred to the proper division/class/lot prior to judging. If such classes have been judged, however, they shall not be reopened. No animal shall be changed from one class to another after closing dates unless it is ineligible for the class in which it is entered.
- All determinations are at the department Superintendent's discretion.

DETERMINATION OF PRIZE WINNERS

- Where there is no competition and/or where there are fewer animals or articles in a class than the number of premiums offered, the judge and Superintendent, at their discretion, may award a prize or prizes of such rank as the animal or article deserves.
- Awards may be marked Blue, Red, White, etc. and will be made according to the merits of the exhibit. The judge may disqualify or award red or white premiums at his/her discretion. Special awards will be made only after the judge has agreed with the department superintendent that such award should be made.
- Where there is one exhibit in a class, the award shall be made on merit alone and a premium or no premiums may be awarded. An animal or article without merit shall not be awarded a premium; and premiums shall not be awarded merely because there is no competition.
- The Danish system of award is used in the FFA Division. Upon request, department superintendent will provide information on specific judging/award systems by division/class.
- Prize winners shall be determined by reference to the judge/clerking sheets. The department superintendent and judge signatures certify the placing to be correct.

DEPARTMENT SUPERINTENDENT

- The FFA division superintendent is an active Vocational Agriculture Advisor for a Snohomish County school district, Cedarcrest School District and Mount Si School District.
- Each department superintendent, under the direction of Fair management and staff, shall have charge of the department to which he/she may be assigned. Exhibitors will follow the order and direction of the superintendent. If the order of the superintendent differs from the rules and regulations in this book, superintendent will provide exhibitor with verification of Fair management approval for deviation from rules.
- Superintendent has the authority to recommend, to Fair management, reducing or removal of premiums when rule violations and/or disciplinary problems exist.
- Superintendent has the right to request certificates of registration and transfer and examine these before the prizes and premiums are awarded, and to notify the judge that the exhibitor has complied with these requirements.

JUDGES

- The judges in all departments will be approved by Fair management. No one will be allowed to act as a judge in the class rings in which he/she exhibits.
- **The decision of the judges will be final in all cases, except where mistake, fraud, misrepresentation or collusion, not discovered at the time of the award, is proven. In such cases, Fair management will make the decision.**
- Fair administration reserves the right to substitute judges as necessary.

PROTESTS AND APPEALS

- All protests and appeals must be made in writing and accompanied by a deposit of \$25.00 cash only. This deposit will be forfeited if protest/appeal is not sustained. Said document must state plainly the cause of complaint or appeal and must be filed with Fair manager within 24 hours after cause of protest/appeal. Submit written complaint in the Fair Administration Office (Building #405).
- Appeals from the decision of a judge or department Superintendent must be made in writing and must contain at least one specific charge stating at length the facts relied upon or the rule violated, and naming witnesses and their addresses by which proof is to be made.
- When a protest is to be made against the competition of an animal or article in any class, notice of same shall be filed with the department

superintendent before the class is passed upon, so the judge may be instructed to place a reserve award in order that premiums may be properly distributed in the event of the protest being sustained.

- No complaint or appeal based upon the statement that the judge or judges are incompetent or have overlooked an animal or article will be considered by Fair management.
- All questions of dispute or difference not provided for under the rules and regulations shall be referred to Fair management whose decision shall be final.
- In addition to the right of protest therein guaranteed to exhibitors, Fair management reserves the right to take cognizance of fraud consummated or attempted in connection with an exhibit and take such action as may be deemed just and proper.

DRESS CODE

- All exhibitors shall wear appropriate dress for the project being exhibited, including FFA jacket. Any questions see Department Superintendent.
- Official dress required for Fitting & Showing – FFA jacket, white collared shirt, FFA Tie or Scarf, pants and footwear suitable for a professional presentation of that species.

EXHIBITOR TICKETS

- One Vocational Agriculture Advisor, from each school, is responsible for acquisition and distribution of fair admission tickets. All eligible FFA exhibitors may receive a fair season admission ticket at the current year rate.

AWARDS

The judges will award prizes and premiums only on articles, divisions and classes listed in this book. An error in the record of premiums and prizes awarded, caused by oversight or neglect on the part of the superintendent or judge, shall be subject to correction by Fair Manager.

MONETARY PREMIUMS

- Each department in this book outlines premium amounts or points applicable to division/classes and lots. If, for any reason such as war, rain or any act of God beyond the control of Fair, the income for the current year of the Fairgrounds shall be impaired, all prizes, premiums, and awards will be pro-rated accordingly.
- Upon agreement between Fair management and FFA superintendent, premium money may be withheld from any exhibitor who displays poor Herdsmanship, poorly fitted animals, improper conduct, and whose exhibit in general does not present a favorable image to the public.

PREMIUM AMOUNTS

- Superintendents recommend, and Fair management approves, the number of points allowed and the flat premium amounts within each department. They are analyzed and determinations made based on what is in the best interest of the exhibitor, Snohomish County and Fair.

PREMIUM WARRANTS (checks)

- Warrants (checks) for premiums will be mailed to exhibitor by the 31st day of October. For exhibitors expecting to earn more than \$500, **W9 forms are required.**

• ANY INCORRECT OR MISSING PREMIUM CHECKS MUST BE REPORTED BY NOVEMBER 30TH.

• REQUESTS FOR MISSING CHECKS WILL NOT BE PROCESSED AFTER DECEMBER 31ST.

- Questions regarding the detailed amounts paid should be directed to the applicable department superintendent.
- To avoid delays in processing premiums, exhibitor is responsible for completing all areas of the Entry Information that apply. It is mandatory that the *Exhibitor Name* and complete *address* are typed or printed legibly on the Entry Form. For exhibitors expecting to earn more than \$500, **W9 forms are required.**
- Premium warrants (checks) are void 90 days after date of issuance.
- LOST premium warrants may be replaced after completing this process. (1) Call or come to the Fair Administration office to request a "Lost Warrant Affidavit" form. (2) Complete form. (3) Mail or deliver form to Snohomish County Administration Building, Department of Budget and Finance, 3000 Rockefeller Ave., Everett, WA 98201.

RIBBONS/ROSETTES

- Awards will be designated by ribbons and rosettes in colors as specified:

First (Excellence).....Blue
Second (Good).....Red
Third (Fair).....White

OTHER AWARDS

- Refer to individual department for information on special and sponsored awards.

NON-ANIMAL DEPARTMENT RULES - FFA ENTRY

- Entries are accepted through on-line entry at <http://egreen.fairwire.com> and must be submitted by the 31st of July. Exhibitors are also encouraged to register for judging contests, posters and exhibits, public education at time of entry.
- Exhibits that are wet or tacky to the touch will NOT be accepted. Exhibitor will complete exhibit within a timeline that virtually guarantees an intact exhibit.
- On entering an exhibit, an *Entry Tag* will be furnished which contains all data pertinent to the exhibitor and exhibit. This tag must be attached to exhibit according to the direction of the Superintendent or Department Clerk.

RELEASE OF EXHIBIT

- All exhibits must remain intact until the release time specified in each department. Failure to comply with this requirement will cause forfeiture of premiums and awards won in any department of the Fair.
- It is the sole responsibility of the owner to retrieve exhibit after the department release time.
- Non-perishable exhibits become the property of the Fair if not claimed by September 8 of the current year.

LIVESTOCK DEPARTMENT INFORMATION & RULES

ELIGIBILITY

- Livestock or animals, for purposes of these rules, are defined as all breeds of beef cattle, dairy cattle, swine, sheep, horses, dairy goats, pygmy goats, fiber animals, Boer goats, poultry, fowl and rabbits.
- Entries in livestock classes are open to purebred or high-grade stock, owned and/or lend-lease and fitted by the exhibitor.
- Exhibitor must be a member of a Washington State FFA chapter.
- Upon entry animals may be used for judging classes in area of contest as seen fit by area Superintendent Use will be required full compliance will be met.

ENTRY AND ADMISSION OF LIVESTOCK and ANIMAL

- Entries are accepted after completion of on-line entry form, AND A HEALTH EXAMINATION OF THE ANIMAL. For exhibitors expecting to earn more than \$500, **W9 forms are required.**
- Check individual departments for pre-entry requirements.
- A limit may be placed on livestock entries. Early submittal of entries is recommended, as livestock is limited to space available.
- All animals must be readily identifiable with an ear tag, leg band, microchip or tattoo. A listing of the identification of individual animals that are part of the student's SAE project should be included on the Animal Inventory page of the Record Book. Front and side view photos of animals shown should be included in the record book.
- Livestock may be unloaded at the fairgrounds during the times listed in the department schedule. Livestock arriving outside those times listed will not be permitted in the barns until checked by veterinarian. Owner will be charged a service fee for the veterinarian to health check the animal prior to admission.
- Following placement of animals in their appropriate barns, exhibitors must proceed to Building 511. At that time they will check all entries for placement in correct classes as well as all other required entries. After this record check, exhibitors will receive their stall cards for their animals. This must be completed by 9:00 pm Wednesday night or exhibitors will be asked to remove their animals.

HEALTH INSPECTION - VETERINARIAN

All livestock/animal exhibits presented for entry to the facilities are **required** to pass a health examination by Evergreen State Fair Contracted Veterinarians during established inspection times of each department. They must be checked in only through the department in which they are to be housed. The extent of examination is to be determined by the Veterinarian and with the following information:

1. An original "Animal Health Certificate" completed within 7 calendar days of animal's arrival will result in a *cursory* veterinarian review unless further symptoms warrant a more extensive examination.
2. If an "Animal Health Certificate" is not provided, a veterinarian's exam will be conducted to the extent deemed necessary by the Veterinarian to ensure the safety and health of all animals at the Evergreen State Fair.
 - No animal from a quarantined area or premise will be permitted to enter the Fairgrounds.
 - The Fair veterinarian's professional decision as to the health status of an animal is final and Fair management will uphold such decisions.
 - At the discretion of the Superintendent or Fair Manager, any animal that will not stand or endangers the Veterinarian, exhibitor, public, or other exhibitors, during the examination will be immediately removed from the grounds.
 - The Evergreen State Fair and the State of Washington establish exhibit health standards for the safety and overall health of all exhibits.
 - Refer to the individual departments for vaccination requirements.
 - There will be no administration of drugs to an animal without the Department Superintendent's knowledge. Refer to "Livestock Exhibitor–Code of Ethics" for any questions on drugs.

INTRASTATE – HEALTH REQUIREMENTS

- Washington State livestock require no vaccinations or tests for entering and individual health certificates are not required on Washington State animals – except as indicated below.

OUT-OF-STATE ANIMALS.

INTERSTATE – HEALTH REQUIREMENTS

- Out-of-state animal entries must comply with State of Washington import regulations. **WA State Permit No. 91-WA22870**
- All out-of-state, except Oregon, horses must have a negative Coggins Test (E.I.A.) within six (6) months prior to Fair.

SPECIFIC HEALTH REQUIREMENTS – BOVINE

- It is recommended that all heifers eligible for Brucellosis (Bangs) vaccination will be vaccinated prior to Fair.
- Non-vaccinated animals may be exhibited provided they are tested negative for Brucellosis over four months of age.
- All eligible animals five (5) months or older must have been vaccinated against Brucellosis.
- PLAN AHEAD ALERT – It requires up to ten (10) days receiving blood test results from the laboratory for animals requiring a Brucellosis test.
- Any animal whose owner cannot produce evidence of vaccination, in the form of a tattoo, must have a negative official Brucellosis test done through a State or Federal laboratory within 90 days prior to the opening of Fair.
- A respiratory complex vaccine is strongly recommended.
- Recommended cattle vaccines are IBR, BVD, PI 3, and BRSV Viral vaccines at least 2 weeks prior to showing at the fair.
- An 8-week clostridial vaccine is also highly recommended.
- All cattle are required to have an ownership inspection (brand) prior to leaving the state of origin.

SPECIFIC HEALTH INFORMATION – OTHER SPECIES

- The following vaccinations are strongly recommended (but not required) by Snohomish County Veterinary Medical Association:

HORSES:

Tetanus toxoid, influenza vaccine, Eastern and Western Encephalomyelitis, Equine Rhinopneumonitis, and a mixed bacterin injection are advised yearly. It is recommended that these vaccinations be given at least 4 to 6 weeks prior to Fair and no sooner than 2 weeks prior to showing if horse is stalling overnight. All horses must have a Certificate of Veterinary Inspection and horses over six months of age are required to have evidence of a negative test for (EIA) equine infectious anemia within six months of entry; all horses are required to have an ownership inspection (brand) prior to leaving the state of origin.

POULTRY:

Exotic Newcastle Disease (END) WAC16-54-155 this section applies to all avian species and commercial traffic originating from the END quarantine zone in California and to bird exhibits, shows, auctions, public displays and competitions held in WA St.

- 1) A promoter of an event in WA St., such as an exhibit, show, auction, competition, or other public display of birds of any type shall immediately inform the State Veterinarian by mail, fax, or email of a scheduled event. The notification shall include the contact's name, mailing address, physical address of the event, and daytime telephone number.
- 2) A promoter of an event in WA St., such as an exhibit, show, auction, competition, or other public display of birds of any type shall inform the event exhibitors and vendors in writing of this WAC and current quarantine for END, and the risk of introducing END into WA St. The promoter also shall require each event exhibitor and vendor to attest in writing that they are not in violation of this WAC. The signed document shall be forwarded to the State Veterinarian within one week of the conclusion of the event. A Certificate of Veterinary Inspection and negative test for Salmonella Pullorum-typhoid within 30 days of entry is required.

SHEEP & GOATS:

Scrapie Rule WAC 16-89 – All Sheep are required to be tagged with an official Scrapie's tag. Goats may be tagged, tattooed or micro-chipped as long as appropriated documentation of Flock Identification is provided.

SWINE:

All swine are required to have a Certificate of Veterinary Inspection and an import permit, which may be a blanket permit for that fair. All swine must be tested negative to Pseudo rabies within 30 days prior to entry or originate from a Pseudo rabies qualified negative herd or from a stage IV or V state/area. All swine over six months of age must be negative to a Brucellosis test within 30 days prior to entry except swine originating from a validated Brucellosis free heard or state. Bordetella, Erysipelas, Pasteurella Leptospirosis and Parvovirus vaccinations are recommended or required.

REJECTION OF ANIMAL/LIVESTOCK

- Any exhibit with indicators of infectious or contagious diseases, ectoparasites or conditions will be rejected. Exhibitors need to be aware that ringworm, warts, pinkeye, strangles, contagious ecthyma, hoof rot, scabies, lice, mites, ticks, and fleas fall into these categories.
- Animals showing indications of disease symptoms during the course of the fair will be rejected by Fair veterinarian and when necessary, exhibitor instructed to remove animals form the exhibit area.

ADJUDICATION OF CLASSES

- No person will be permitted in the ring while stock is being judged except the judge and necessary attendant. Any person interfering with the judges during their adjudication will forfeit the right to premiums. All officers are required, and exhibitors requested to report any violation of this rule to Fair management.
- All agricultural products will be judged by a scorecard system.

STALL/PEN/CAGE OCCUPANCY

- The department superintendent is solely responsible for assignment of exhibit space within barns, except where otherwise noted. Completed entry form(s) must be submitted to Superintendent prior to assignment of space.
- Under no circumstances will an animal, unless it is entered in a livestock department, or authorized for exhibition, be allowed to occupy a stall or pen until all exhibition animals are accommodated. After said animals have been provided for, should there be any available stalls or pens; exhibitor may make application to superintendent to occupy space.
- Exhibitor is required to leave stall/pen/cage in the same or better condition than it was upon exhibitor's arrival.

DISPLAY OF LIVESTOCK

- All animals must remain un-blanketed from 10:00 am until 9:00 pm on each day of the fair. Exceptions: 1) Sheep 2) The day the animals are groomed for judging. 3) Judging day when they may be blanketed prior to the show. Refer to department superintendent for further clarification.
- Animal exhibits are not allowed out of the general vicinity of the barns and show rings. Exceptions made with superintendent approval only.

LIVESTOCK EXHIBITOR – CODE OF ETHICS

Believing it is in the best interest of all breeders of all livestock to maintain a reputation of integrity and to continue to present a wholesome and progressive image in the show-ring, Fair management lists herewith those practices, which are considered **unacceptable** in presenting livestock in the show ring. The use of such practices or procedures is, therefore, considered unethical in the showing of livestock at the Evergreen State Fair.

1. Misrepresenting the age of the animal for the class in which it is shown.
2. Treating or massaging any part of the body internally or externally with an irritant, counter-irritant, or other substance to temporarily straighten a weak back or loin, or to produce unnatural animation.
3. Minimizing the effects of cramping by feeding or injecting drugs, depressants or applying packs or using any artificial contrivance or therapeutic treatment for exempting normal exercise.
4. Striking the animal to cause swelling in a depressed area.
5. Surgery of any kind performed to change the natural process or growth, maturation, contour or appearance of any animal, to include teeth. Not included is removal of teats or horns, clipping and dressing of hair and trimming of hooves.
6. Insertion of foreign material under the skin to change the natural contours of the animal.
7. Any attempt to change natural color of an animal, either purebred or crossbred, by changing the color or adding false hair, fleece or skin at any point, spot or area of the animal's body.
8. The use of alcoholic beverages in the feed or administered as a drench.
9. Administration of drugs of any kind or description, internally or externally prior to entering the show ring, except for treating a recognized disease or injury and for the tranquilizing of bulls that may otherwise be dangerous to females in heat.
10. Balancing the udder by any abnormal means including the use of a mechanical contrivance or the injection of fluid or drugs.
11. Treating or massaging the udder or its attachment with an irritant or counterirritant. The use of common products such as fly spray, ointment or liniment in excess to the extent that irritation is included as an irritant unless required to reduce edema at time of calving.

For the purpose of these rules/code of ethics, the term "drug" shall mean any substance, the sale, possession or use of which is controlled by license under federal, state or local laws or regulations and by any substance commonly used by the medical or veterinary professions. The use of any chemical and/or compound that is not approved by the Food and Drug Administration (FDA) for use in meat producing animals, and the illegal use of approved chemicals and/or compounds are prohibited. All animals shall be subject to tests (blood, urine and/or tissue) for foreign substances that exceed the acceptable levels established by the United States Department of Agriculture, or the FDA. A positive test may result in disqualification, forfeiture of premiums and/or awards.

BUILDING OCCUPANCY

- All decorative materials must be fire retardant.
- Furnishings, Food Preparation Storage equipment will not be allowed in any Livestock Barn.
- Appropriate (FFA) Fair stall card must be displayed in decorating theme.
- Electrical equipment and appliances used by exhibitors shall be properly shielded, grounded, if necessary, for safe operation; and all electrical cords shall be in good condition, without breaks in insulation. All electrical plugs shall have covers to insulate wire or connections from receptacle faces.
- Such precautions shall be the responsibility of the user, but Fair may inspect at any time all electrical equipment and may impound, for the duration of the Fair, any equipment considered unsafe.
- Smoking is prohibited in all fairground's buildings.
- **Building/barn occupancy is prohibited, to exhibitors and the public, between 11:00 pm and 5:00 am.** Exceptions may be made by the department superintendent in the case of animals under a veterinarian's care.

VEHICLE TRAFFIC

- Traffic in the vicinity of show buildings and barns will move one direction during times of entry and release.
- Multi-Day parking tickets are available in advance at the Fair Pass Booth (bldg. #202).

LIVESTOCK TRAILER PARKING

- There is FREE livestock and horse trailer parking in DESIGNATED areas assigned by Fair.
- Livestock trailers used to haul animals during the current fair season are not allowed to park in RV parking areas.

HERDSMANSHIP

- Exhibitors will be required to keep their spaces and stalls clean by removing any trash, litter or soiled bedding, and place it in the designated area.
- Exhibitor is responsible for supplying all tools associated with Herdsmanship including but not limited to wheelbarrow, shovel and pitchfork.

FEED & BEDDING

- Exhibitor is required to provide all feed for livestock and animals on exhibit. Feed must be stored in rodent proof containers.
- In most cases feeders and water containers are provided by the fair. Verify availability with the department superintendent.
- Bedding resources are getting difficult to obtain; the Fair will be notifying you of new Policies and Procedures for bedding.

VETERINARIAN-CLIENT RELATIONSHIP

- Twice daily, the fair veterinarian will make on-site service calls to respond to animals listed on the "Vet Check List".
- Any expenses incurred in regard to the examination and/or treatment of any animal exhibited at the Evergreen State Fair will be the sole responsibility of the owner of said animal.

TIME OF CLASSES/SHOWS

- As much as possible, the schedule set forth in the individual departments will be followed. Fair management reserves the right to alter or cancel schedules as is required by circumstances.

RELEASE OF LIVESTOCK

- Exhibitor may remove livestock on exhibit only at the times set forth in the individual department schedule. Removal or withdrawal of animal/livestock prior to release time may place premiums and prizes subject to cancellation.

ANIMAL ACTIVIST ALERT

- At all times the exhibitor shall be aware of suspicious activity such as, out of the ordinary photographing of animal or exhibitors', and questioning of a suspicious nature.
- In the event of potential animal activist activities, the following actions should be taken:
 - 1) Exhibitor shall contact the department superintendent or other department official.
 - 2) Exhibitor and attendants should remain calm and conduct business as usual. Remember, the activist's goal is to draw attention and cause a disruption.
- The fair and its users are protected under Public Law 102-346 passed August 26, 1992, by US 102d congress. Refer to Animal Enterprise Protection Act of 1992 – Section 43.

UNDER NO CIRCUMSTANCES SHOULD EXHIBITOR SUBMIT TO INTERACTION WITH THE ACTIVIST.

Alert – Fireworks display will be on Thursday, August 25; 9pm – 9:10pm and on Sunday, September 04 following the auto races. Please take the necessary steps to ensure the safety of your animal.

MEMORANDUM OF UNDERSTANDING

A shared understanding between WSU Cooperative Extension (4-H) and Agricultural Education, Washington FFA Association, exists to foster expanded participation and opportunities. The Evergreen State Fairgrounds supports and encourages both programs by adhering to the principles established as a code of ethics for participation. Below are Fair related components taken from the Memorandum of Understanding for your information!

MEMORANDUM OF UNDERSTANDING
Between
AGRICULTURE EDUCATION
WASHINGTON FFA ASSOCIATION
and
WSU EXTENSION
4-H YOUTH DEVELOPMENT PROGRAM
concerning
4-H AND FFA PROGRAM OPERATION IN
WASHINGTON
STATE

Agriculture Education/FFA and the 4-H youth development programs in the state of Washington are carried on for the purpose of promoting the maximum development of the members participating in these activities. We recommend that the following principles be considered a "code of ethics" for carrying on the two programs:

1. Agriculture Education teachers should encourage students to enroll and continue in the 4-H program.
2. County extension agents and adult volunteer leaders should encourage members to enroll in agriculture education classes available to them in their local secondary schools and to become members of the Washington FFA Association.
3. A member may participate in all judging or bowl division activities in FFA and 4-H, unless contests are held simultaneous, then the member must choose.

4. Members simultaneously enrolled in 4-H and FFA must carry separate and distinct projects or animals during the same calendar year. The program year is defined as October 1 to September 30. Both organizations desire to help in the education of youth. Involvement in both programs should result in doubling of the educational impact on the individual.

5. No member will be permitted to exhibit the same product or individual animal in both FFA and 4-H divisions. Inventory record proof of projects must accompany article/animal at time of entry at exhibit/fair event.

6. Publicity should reflect the contributions of each organization, giving the full story with respect to the contribution of both organizations when a joint contribution has been made in the development of the individual and their projects.

7. For the benefit of both organizations (4-H and FFA) separate division should be provided in all fairs in the state to eliminate competition between the members of the two organizations. Champions representing the two organizations will not be brought together in competition. However, when the situation in the community or a particular fair or youth show indicates that creations of a youth division (without 4-H and FFA identification) would be desirable, a single division may be organized with the agreement of the local agriculture teacher and FFA advisor, the county extension agents and show management, and with the concurrence of the state leaders in 4-H and FFA. Local fairs/shows may set up special rules and regulations for the management of that event; however, they must be in accordance with the Memorandum of Understanding. It is recommended that district or county meetings be held with agents and vocational agriculture and natural resources teachers periodically to discuss their roles and to determine local application. Frequent contact between the agents and teachers for mutual support and planning of leadership development programs are encouraged.

9. For livestock trailer parking information, refer to LIVESTOCK INFORMATION at front of book.

14. All goats must be identified for Scrapie's. Animals may be tagged, tattooed or microchipped as considered appropriate for the breed. Appropriated documentation of Flock Identification must be provided.

15. It is strongly recommended that goats be vaccinated against respiratory diseases and wormed at least two weeks prior to the fair. Exhibitors using sore mouth vaccine should administer it a minimum of 45 days before the fair.

16. No blankets allowed on the animals between 8:00 a.m. and 10:00 p.m. Exception: Fitting & Showing day.

17. The official ESF stall card must be used to describe all exhibits.

18. Acceptance and placement of large informational and educational exhibits will be at the superintendent's discretion.

Department Rules:

1. Advisor shall enter all Herdsmanship for the chapter.
2. Herdsmanship will be judged by the Barn Superintendent Daily.
3. All persons exhibiting animals in the Fair **must** participate in Herdsmanship and Fitting & Showing unless excused by Advisor **and** Department Superintendent.
4. Stalls and other FFA exhibit areas will be judged multiple times each day of the FFA section of the Fair.
5. **Parents or leaders may direct but not participate in the care or cleaning of animals, pens, or stalls.**
6. Herdsmanship is awarded to a school FFA Chapter. Exception: Individual is awarded points if they are the only student, from that school, exhibiting in the department/project (e.g., beef, sheep).
7. Horticulture Herdsmanship is required for chapters exhibiting landscapes. A School Representative must be on site from 9am – 6pm. Landscape displays must be watered hourly while students are on Herdsmanship. If Horticulture Herdsmanship is not completed, the chapter will not receive premiums for their landscape.

Judging based on:

I. ANIMALS

Animal areas are judged on cleanliness, grooming, condition of animal, arrangement and regularity of feeding and watering.

II. STALLS, PENS, EXHIBIT AREA

Stalls, pens and exhibit areas are judged on bedding, arrangement of equipment, supplies, cleanliness, orderliness, and neatness. You are also expected to keep your tack area neat and organized. Wash racks are also a part of your Herdsmanship.

III. EXHIBITORS

Exhibitors are judged on attentiveness, appearance, attitude, courtesy and skill in handling your animals will be considered part of your score. At least one person should be on duty, or no points will be allowed. If there is only one exhibitor for a school, you can ask a neighboring school to help watch your exhibit part time. Some barns and areas may do group Herdsmanship. Check with your Superintendent at the beginning of the fair for more information.

IV. EDUCATIONAL AND DISPLAY EFFECTS

Each animal and exhibitor will be identified by a ESF stall card or entry tag. Display cards and ribbons neatly along with a sign talking about each exhibit (names, age, breed, weight, whether breeding animal or

any other applicable special characteristics). These cards should be the same size as your stall card and displayed above them.

DEPARTMENT RULES:

3. All entries must have a record book, which needs to be completed and turned in by Thursday (first day of fair) at noon. The record book can be found on-line at www.evergreenfair.org. Exhibitors may also use the AET Record Keeping system provided they print reports that provide the same information as requested in the Evergreen State Fair Record Book.
4. **POSTERS ARE REQUIRED FOR ALL ANIMAL EXHIBITORS FOR THE DEPARTMENT IN, WHICH THEY ARE EXHIBITING.**
5. All persons exhibiting Horses in the fair **must** clean up trailer areas and participate in Fitting & Showing unless excused by Advisor **and** Department Superintendent.
6. FFA program parents and advisors may direct but not participate in the care or cleaning of animals.
7. Acceptance and placement of informational and educational exhibits will be at the Ag Teacher Building #511 on Wednesday prior to 10:00 pm. These posters will be hung in the agricultural and livestock areas during the first half of the fair. Exhibitors are required to pick these up on the Tuesday of the fair.
8. Any exhibitor or adult displaying unacceptable conduct (i.e., profane language, abusive treatment) may at the discretion of superintendent and fair management, be dismissed and jeopardize awarding of points/premiums. The possession or use of alcohol, tobacco or drugs will result in immediate removal of the exhibitor and their exhibits from the fairgrounds and the exhibitor will forfeit all points/premiums.
9. Dress code regulations are outlined in the front of the book.
10. All FFA members must be under adult supervision.
11. **Limited to two entries per entry code.**
12. Horses must be an FFA project and may **not** be shown in both 4-H and FFA concurrently. Students must show Project Agreement and complete a record book of their project to receive premium money.
13. Horses and Ponies with active 4-H certificates on file may not be exhibited at the FFA Horse Show.
14. No member may show a stallion over 12 months of age.

VET CHECK:

15. A horse or pony may be refused admittance at the veterinarian's discretion.
16. Any horse or pony transported with an infected animal may also be refused admittance.
17. The exhibitor is encouraged to consult their veterinarian regarding the health status of their horse prior to fair.
18. The Superintendent and Veterinarian have the authority to inspect any animal on the grounds during the event and, in the event the animal is injured, sick or suspected of having a contagious disease, they have the authority to discharge any animal.
19. It is strongly recommended that all horses be vaccinated against influenza, Rhinopneumonitis and wormed within six weeks of the fair. Tetanus vaccination and teeth examination within the last year is also recommended. Vaccination against Strangles should be considered for younger horses.
20. Other than initial vet check, owner is responsible for payment of any treatment requiring a veterinarian's attention while at the Fair.

EQUIPMENT AND DRESS:

21. For Fitting & Showing and Halter Classes, participants must wear black pants and appropriate footwear as well as an FFA Jacket, FFA scarf or tie and a white buttoned shirt.
22. FFA official dress attire (above the waist) is required in all riding classes, with the exception of gaming classes.
23. **HELMETS AND BOOTS ARE REQUIRED FOR ALL PARTICIPANTS AND MUST BE WORN IN ALL RIDING CLASSES.**
24. Numbers must be worn on the exhibitor's back or approved side displays and must be clearly visible at all times when in competition.
25. **TACK GENERAL:** All equipment should be clean, in good repair, and should fit the horse and rider. Halters should fit well, must have a throatlatch and it is recommended that they are made of nylon web or leather. (Rope halters are not recommended.) Leads may be rope, web or leather, with or without a chain, and equipped with a snap. Chains may be used under the chin or over the nose if the horse has been trained that way. Silver in tack will not count in placing of classes. Show halters with snaffle bits permissible. Full bridles allowed according to breed.
26. Proper equipment required:
 - a) When riding, exhibitors must have bridles on their horses. (Hackamores are acceptable in gaming events and green Horse's classes.) Halters should not be used as bridles.
 - b) Rider/handler must wear boots at all times when riding, Lunging, or leading a horse.
27. Western Pleasure and Western Equitation horses need to be shown with leverage bits, chinstraps are required and no tie downs. Green Equitation and Green Pleasure exhibitors may use snaffles and tie downs.

CLASS GUIDELINES:

- All exhibitors are required to show in one fitting & showing class.
- All animals must be shown in halter classes.
- Exhibitor may enter one Fitting & Showing class only. Exhibitor may not fit and show both pony and horse.
- Horses and ponies may not cross-enter events.
- Any exhibitor not having his/her horse under sufficient control will be dismissed from the ring.
- The classes will be judged under the Danish System, wherein each exhibitor will be awarded a blue, red or white ribbon.
- A champion ribbon will be awarded to the blue-ribbon winner who is judged as representing the best in that category. Rosettes are awarded at the judge's discretion.
- Members may enter in several categories. Premiums will be paid on a maximum of (7) seven premium-paying classes; one must be a Fitting & Showing class.

BARN/GROUNDS REGULATIONS:

- Exhibitors must park in back row trailer parking NOT in RV parking Spots. Exhibitors must remove manure at the end of the day.
- Horses must be attended at all times.
- No horses may enter the barn areas.
- Outside wash racks by Barn #105 and #106 may be used to wash horses. Exhibitor must provide hose.
- Apply hoof polish outside. Stand horse on a mat or piece of cardboard so hoof black does not get on the pavement.
- Exhibitor must lead horse, via pedestrian walkways, between barn and exercise/show areas.**
- No horse or pony will be ridden above a walk unless in one of the rings or in an area that is posted for warm-up.
- Riding, grooming, schooling, and handling of a horse is limited to FFA exhibitor, with the exception of handlers for the Horse Judging Career Development Event.
- One person only allowed on a horse at a time.
- Lunging of horse in designated areas only.
- Coaching of exhibitor, while they are in the show ring, is prohibited.
- Abuse of horse by any person is forbidden and will result in barring the offender from participation and may jeopardize awarding of points/premiums and awards.
- Superintendent and Fair Management may withhold premium money for misconduct or breaking of rules.

DEPARTMENT RULES:

1. Read General Rules and Information.
2. On-Line Entries due by the last day of July. Exhibitors can register on-line at <http://egreen.fairwire.com>.
3. Horticulture is judged for Herdsmanship during the FFA portion of the fair. Exhibitors shall maintain exhibit throughout the FFA portion to be eligible for horticulture Herdsmanship premium.
4. Horticulture landscape premiums paid to school chapters only.
5. FFA program parents and advisors may direct but not participate in the design and installation of landscape designs.
6. All exhibits must be presentable to the public and on display in assigned area during public hours (exception: judging/showing and practice times).
7. Acceptance and placement of informational and educational exhibits will be at the Ag Teacher Building #511 on Wednesday prior to 9:00 pm. These posters will be hung in the agricultural and livestock areas during the first half of the fair. Exhibitors are required to pick these up on the Tuesday of the fair.
8. Any exhibitor or adult displaying unacceptable conduct (i.e. profane language, abusive treatment) may at the discretion of superintendent and fair management, be dismissed and jeopardize awarding of points/premiums. The possession or use of alcohol, tobacco or drugs will result in immediate removal of the exhibitor and their exhibits from the fairgrounds and the exhibitor will forfeit all points/premiums.
9. For livestock trailer parking information, refer to LIVESTOCK INFORMATION at front of book.
10. Dress code regulations are outlined in the front of the book.
11. Entries open to all persons currently enrolled in a Washington State FFA chapter.

RULES FOR EXHIBITING VEGETABLES

1. Only vegetables of marketable quality will be considered. Enter as many varieties as you like.
2. Suggestions for selecting vegetables and fruit for fair exhibition:
ROOTS – Leave tops approximately 1 inch long on crops such as carrots, beets, parsnips, turnips, wash carefully.
BEANS – Tender and without string. Uniformity extremely important, (no noticeable bulges due to enclosed beans) leave ½" stem.
CABBAGE – When peeling, leave one set of leaves that will be removed in preparing the cabbage for the table.
CARROTS – Avoid injury by severe washing. Smoothness and a genuine carrot color usually accompany good quality.
CORN – Cut straight with tips and butts of full size and filled to the end.
CUCUMBERS – Use a knife when picking. Leave half-inch stem on.
ONIONS – Remove only as many outer husks as necessary to make onions look clean and attractive. Root may or may not be removed.

Leave 6" top on leeks and green onions, ½" bulb on green onions.

PARSNIPS – Avoid breaking tips, 2-3" diameter at crown best.

PEPPERS – Exhibit green or red.

POTATOES – Good average commercial size. Dig and wash carefully.

PUMPKIN AND SQUASH – Exhibit varieties called for. Leave 2" of stem. Crookneck, Scallop or Zucchini shell should be penetrable by thumbnail.

TOMATOES – Green stems may or may not be removed. Use scissors.

TURNIPS – Good average size. Do not remove tails.

SOW AND LITTER DISPLAY

ATTENTION: All Swine Exhibitors

There are a limited number of openings for the contracted sow and litter displays at the 2025 Evergreen State Fair in Monroe. Those exhibitors that wish to be considered for these positions must contact the Swine Division Superintendent, for an application.

Application cut-off date is August 1, 2025

Successful candidates are contracted and paid a flat fee for displays accepted under the following conditions:

1. **DISPLAY** shall consist of one sow and a litter of not less than seven (7) piglets born on or after August 1 of the current year.

2. PERIOD OF STAY:

- Exhibitor must have all animals hauled in by 8:00 p.m. on Wednesday.
- Display shall be ready for the public by 10:00 a.m. on Thursday.
- Display shall remain open to the public between 10:30 a.m. and 9:00 p.m. daily, throughout the fair up to Labor Day and between 10:30 a.m. and 6:00 p.m. on Labor Day.

3. HEALTH RECOMMENDATIONS:

- Vaccination records must be current, and animals must meet all fair livestock requirements (refer to front of this book).
- All animals shall be clean and in good conditions, free from ticks and lice.

4. HERDSMANSHIP:

- Shall be the responsibility of the contractor or designee.
- Pens must be kept neat and clean, tack neatly displayed.
- Herdsmanship will include a representative present at the display during all public hours. Representative must be able to field questions on swine, the sow and litter in particular.
- Examples of information representative must be prepared for:
 - a. How many were born?
 - b. How much does that sow/litter eat?
 - c. How much water do they drink?
 - d. How much space do they need?
 - e. How fast do they grow?
 - f. What is the gestation period?
 - g. What do the notches in their ears mean?

5. **EXHIBITOR** will be required to enter into an agreement, which includes a Hold Harmless clause.

6. COMPETITION/JUDGING:

- Display will be judged for ribbons only, no premiums paid
